**Agenda Item 7.4** Ordinance O-08-06-Introduction and Read by Title Only

Mayor Shay read the ordinance by title only.

Chief Fessler reviewed the staff report and the issues surrounding the use of these transportation devices on public streets. There are very specific circumstances that apply in these cases.

Councilor Gibson asked about the ability to utilize these vehicles in the areas outside those described in the ordinance. Chief Fessler replied that State law, in its current form, would prohibit that use.

Councilor Locklin questioned the provisions allowing bicycles on sidewalks while not allowing other devices(skateboards, etc) on sidewalks.

Councilor Winn questioned allowing any new use of sidewalks by alternative transportation devices that are not properly equipped with safety device(brakes).

Councilor Turley asked for copies of the pertinent code sections referenced in the ordinance.

Staff will supply the copies and provide a cost estimate for implementing the signage and the permit program.
